Rationale

Day to day operations of hospitals require human, technical and conceptual skills, like any other organisation. Hospital Administration is responsible and accountable for its functioning to the owners of hospitals, employees, patients, visitors and the public at large. Hospitals also enter into various contractual obligations for employment, business activities and safety operations. All these activities have to be in a prescribed manner and are liable to legal scrutiny.

Hospital is an industry and thus falls under the purview of various acts related to maintenance of industrial relations. Besides the Health Laws, other laws like Industrial Dispute Act 1947, Maternity Benefits Act 1926, The Contract Labour (Regulation and Abolition) Act 1970, The Trade Union Act 1926, Payment of Wages Act 1936, Minimum Wages Act 1948 etc are also applicable to hospitals.

With the rising public expectations and increased awareness, the public is exercising its Rights and the numbers of litigations against hospitals are increasing. Every doctor, infact all staff in hospitals should be conversant with important legal issue involved in patient care.

In view of the importance of legal issues in day-to-day functioning, this course has been designed to train the participants to deal with medico legal issues in hospitals and their management. The course will also cover Consumer Rights, Consumer Protection Act and Hospitals, Right to Information Act, Sexual offences at workplace and Legal issues involved in day to day working of each Department of the hospital. Finally, the course aims that participant understand the legalities involved in day to day operations of the hospitals and take preventive steps to minimize litigations against the hospital.
