


About Us

Area of Specialization

The specialization offered is subject to availability of supervisor and the institute's decision shall be final and binding. Various sub-themes can be adopted by the scholar within the specialization in discussion with the supervisor allotted.

Course Work (Mandatory)

Credit Course Requirement

The academic programme comprises a total of 30 credits, delivered over two semesters, each with a duration of six months. In the first semester, scholars are required to complete four courses and present one credit seminar. Similarly, during the second semester, scholars must complete four courses and present one credit seminar. Of the total courses, three are stream specific. Each course carries three credits, inclusive of the seminar component.

Duration for Learning credits

All the credits specified above shall be earned within a maximum of three years from the date of admission to the Programme. Extension after the three years shall be approved by the Committee for a period of one year with a review of progress every six months. Final approval shall be given by the Director of the Institution.

Credit Course Requirement

The academic programme comprises a total of 30 credits, delivered over two semesters, each with a duration of six months. In the first semester, scholars are required to complete four courses and present one credit seminar. Similarly, during the second semester, scholars must complete four courses and present one credit seminar. Of the total courses, three are stream specific. Each course carries three credits, inclusive of the seminar component.

Comprehensive Examination

Each fellow will be required to undertake a comprehensive examination to get the degree on completion of the course work. The performance of the fellow in each module will be evaluated by the following Internal Assessment (30%); and b) End-Term Examination (70%). The minimum of CGPA of 6.5 on a 10-point scale or 60% is required for passing Course/ Seminar. A candidate getting less than 60% shall be given one more opportunity to repeat the Course/Seminar. If he/ she still does not pass in the Course/ Seminar, he/ she shall be terminated from the Fellow Programme. Attendance is mandatory for completion of each course. The policy of attendance will be according to the Institute rules during the course work.

Monitoring and Evaluation

During the program duration every scholar will be monitored regarding their academic and research progress. FPM research requires a high level of intellectual rigor. The objective is to provide an unbiased assessment of the student's progress and the quality of their work, helping to maintain fairness and consistency across the program.

Faculty Advisory Committee

A Faculty Advisory Committee (FAC) that has the Academic Dean, FPM Coordinator, two faculties as members will be constituted for each student to advise and mentor the students till completion of the coursework. The FAC will conduct regular meetings with the scholars to track completion of key milestones like coursework, seminars and comprehensive examination, provide mentorship and support to address any challenges the scholars may face regarding the same. Attending such FAC meetings is mandatory for every scholar.

Research Advisory Committee

To monitor the research related activities a Research Advisory Committee (RAC) having Director, FPM Coordinator, Supervisor (s), One Internal Faculty and two External Industry Experts as members will be constituted for each scholar. The committee members, who are experienced academics and researchers, will evaluate the research proposal, methodology, and findings to ensure they meet the standards of the academic community and contribute meaningfully to the field of healthcare management. Every important activity phase of the FPM thesis from formulation to viva – voce will be monitored by the RAC members.

RAC members based on their multidisciplinary experience will also be able to provide necessary inputs whenever necessary that will help the scholars take up their research work seamlessly. RAC will also provide support to handle challenges the scholars may face with research direction, resource constraints, delay in reaching milestone or problems in the student-supervisor relationship. The scholar is required to submit mid-term progress report once in six months to the RAC.

FPM Student Research Board

To facilitate FPM research, FPM Student Research Board(SRB) (with six members) has been constituted. The FPM SRB will work under the guidance of the Director IIHMR Delhi. Their objective is to assess the proposed protocol of the scholar in relevance to ethical checks undertaken by the scholar. The review of SRB would be shared with the Chairperson of the Institutional Ethics Committee (IEC) of IIHMR Delhi by Dean (Research) for final approval. The IEC can give one of the following decisions:

- Approved – with or without suggestions or comments.
- Revision with minor modifications/amendments – approval is given after examination by the Member Secretary or expedited review, as the case may be;
- Revision with major modifications for resubmission – this will be placed before the full committee for reconsideration for approval; or
- Not approved (or termination/revoking of permission if applicable) – clearly defined reasons must be given for not approving/terminating/revoking of permission

The FPM SRB will follow the research policy of IIHMR Delhi for providing the clearance.

Thesis Formulation & Study

The FPM program culminates in the completion of a research thesis, based on the original research undertaken by the scholar that makes a substantial theoretical and practical contribution to the field of management. It involves structured progression of key milestones from registering the thesis topic to final defence of the work through viva voce.



Pre-registration Seminar

The fellow shall give a pre-registration seminar before the Research Advisory Committee (RAC) constituted by the Director. This Seminar shall be given after completion of the academic modules. The fellow shall submit hard and soft copies of the pre-registration Report (in about 15-20 pages) 15 days before the date of the Seminar. The Report shall include the proposed title of the Thesis, and framework of the proposed research objectives, scope of the study, literature review, hypothesis if any, and methodology to be followed.

Thesis Topic registration

A candidate must apply for formal registration within one month after successful completion of the pre-registration Seminar. The application for registration is to be made in a prescribed form, accompanied by title and summary of the Thesis proposal approved by the Guide(s).The registration shall be effective from the date of application approved for the registration.

Ethical Clearance

Ethical clearance is required for a Fellow Programme in Management (FPM) thesis to ensure the research is conducted responsibly, protects the rights and well-being of participants, and maintains the credibility of the academic work. It also ensures that there is compliance with Institutional and External requirements. The FPM SRB will review the proposal, tools, steps taken by the scholars to ensure confidentiality, privacy, voluntary participation, legal compliance and supporting documents that are provided as evidence. This must be obtained within two months of thesis topic registration. Once the FPM SRB provides clearance, the scholar can start the actual data collection.

Thesis Field Work

After submission of synopsis and obtaining ethical clearance, the scholar should carry out the field work related to the study. The scholar is encouraged to meet the guide(s) regularly and submit the six-month progress report without fail. Also, any academic requirement that needs to be completed should be carried out by the scholar.

Thesis Submission

After completion of the work a thesis needs to be submitted with necessary certificates and clearance for evaluation towards FPM degree. This involves the following stages:



A. Completion of Thesis Pre-requisites

- **Requirement for Teaching Assistantship:** The purpose of the FPM is to rigorously prepare scholars for outstanding careers in teaching/ research, there is a need to build collaborative research / teaching skills. Keeping this in view, the Institute offers opportunity for the scholars gain experience in academics by contributing to the academics related activities which may include lecturing for the courses included in the post graduate management curriculum of the Institute, case material preparation, course design, grading, etc. FPM scholars are expected to provide such teaching assistantship for a minimum of one course as a pre-requisite to thesis submission. This can be opted in the second or third year as per the feasibility of the scholar and requirement of the faculty.
- **Publication Requirement:** The Research undertaken by an FPM scholar is expected to provide sufficient basis for writing papers in refereed academic journals. One of the objectives of the Fellow Programme is to prepare scholars for academic work and research. It is mandatory for the FPM scholar to publish at least two papers in reputed peer reviewed international journals, in well-known classification lists like Clarivate analytics, Scopus Index Score or journals approved by UGC. The article can be a review article, primary data based and case report. The scholar should be the first author for this purpose. The published article should be approved by the guides, have IIHMR affiliation and tested for plagiarism and AI content in the Institute's library.
- **Conference Attendance/ Presentation:** Every research scholar is expected to attend one or two conferences every year while undergoing research study. Minimum attendance in two conferences with a paper/ poster presentation in one is a mandatory fulfilment that will allow the scholar to submit the final synopsis for thesis and award of degree.

B. Pre-Thesis Synopsis Submission

- Once the scholar has completed the field work and carried out the analysis and interpretation of their work, they can submit their Pre-Thesis Synopsis as a prelude to thesis submission. The scholar should submit a Pre-Thesis Synopsis report to the FPM department. It is to be submitted through the Guide(s) to the FPM department.
- For seeking the approval, the candidate shall present Pre-Thesis Synopsis Seminar before a special Synopsis committee constituted for this purpose. The Committee shall judge the work regarding its acceptability and suggest modification or elaboration of the work if necessary. After incorporating the suggested changes/ modifications to the satisfaction of the Committee, an comprehensive version of the same not more than 100 pages shall be submitted as the Final FPM Synopsis for the purpose of sending it to the prospective examiners.

C. Pre-Thesis Seminar

- Prior to submission of the FPM thesis for evaluation, a Pre-Thesis Submission Seminar will be conducted in the Institute, where the scholar is required to present the research work done by him/ her as highlighted in the Synopsis. This seminar will be open to all faculty and students at the Institute. Any suggestions or clarifications that arise during the seminar should be incorporated into the thesis and submitted as the FPM thesis for evaluation

D. Thesis Submission

- The scholar shall submit his/ her thesis in six changed copies of written/ printed copies and a soft copy with necessary certificates and clearances within a period of 6 months from the date of submission of the Final FPM Synopsis.

Viva Voce

The thesis will be evaluated by panel of experts who had agreed to evaluate the thesis based on the Final FPM Synopsis. The expert list will be finalized by the Director of the Institute and will be invited by the Examination Controller to evaluate the thesis. These evaluators selected to form thesis evaluation panel will be academicians or industry experts with ample research background and experience in the domain of the work carried out by the scholar. Once the thesis is evaluated and approval obtained from the evaluators, a viva-voce examination allowing the candidate to defend his/ her thesis will be conducted before a panel of experts.

On successful completion of the viva-voce and on the recommendations of the Institution's Governing Board, the Institution shall award "Fellow in Management" to the Research scholar. The title of the thesis with photo of the scholar shall be mentioned in the certificate of award.

If the thesis needs any modification or changes as suggested by the evaluators, it should be re-submitted with changes within a year. Only then viva voce examination can be conducted. If the thesis is rejected by one evaluator, then another evaluator will be requested to evaluate the thesis. If both the members reject the thesis stays rejected.

Admission Guidelines

The Programme is designed to train and skill scholars with good academic background, strong motivation, discipline and keen in conducting good quality research in healthcare management. The candidates should be highly motivated to pursue research or teaching career in academia. Excellent written and verbal communication are must.

Eligibility

The candidates for the Programme must have one of the following qualifications obtained from any of the universities incorporated by an act of the central or state legislature in India, or other educational institutions established by an act of parliament or declared to be deemed as a university under section 3 of UGC Act, 1956, or possess an equivalent qualification recognized by the Ministry of HRD, Government of India, or an equivalent qualification from an institution approved by AICTE. The degrees of candidates from foreign universities must be recognized by the Association of Indian Universities (AIU).

PGDM from Indian Institutions recognized as equivalent to MBA by AIU and approved by AICTE.

OR

Master's degree or its equivalent in any Health and Social Science/ Allied discipline with a minimum of 60% aggregate marks (Relaxation of 5% is given to SC/ST candidates)

OR

Five-year Integrated Master's degree in any discipline, with a minimum of 60% aggregate marks (Relaxation of 5% is given to SC/ST candidates) or equivalent grade point average, obtained after completing the higher secondary schooling (10+2) or equivalent.

OR

Four Year/Eight Semester M.B.B.S/M.D. S/BAMS/ B.Sc. Nursing Bachelor's Degree in Computer Science and Information Technology (B.E./B.Tech.) with a minimum of 60% marks (Relaxation of 5% is given to SC/ST candidates) or equivalent grade point.

Those appearing for their final examination in the respective discipline can also apply. Such students if selected shall be provisionally admitted provided they complete all requirements in obtaining their master's degree before 30th September of the year of admission. The admission of these candidates shall remain provisional until they produce the mark sheet proving that they satisfy the eligibility criteria. The deadline for submitting the final year mark sheet is 31st December.

Age Limit: There is no age restriction.

Gender Criteria: The Fellow Program is open to all genders

Admission Procedure

Start of the Session

Fellow Programme shall normally be started in Aug/Sep month every year.

Application Procedure

The application shall be made available in the prescribed format in the Institution and available on the website. Attested copies of all the necessary certificates and testimonials are to be attached with the applications. The candidate must submit an abstract of about 5000 words on the area of research interest (tentative research proposal) along with his/her application.

Selection Criteria

Selection for the Fellow Programme in the Institutions approved by AICTE for the Fellow Programme shall be based on the following criteria:

- i. Academic qualifications and work experience
- ii. Fellow Program Evaluation Test (FPET) that will be conducted by IIHMR Delhi
- iii. Tentative research proposal and its presentation before the Selection Committee
- iv. Personal interview

The decision of the Institution Fellow Programme Selection Committee (FPSC) regarding admission shall be final.

Communication shall be sent only to the selected candidates. The Institution shall not entertain any queries or correspondence in respect of those not selected.

FPSC will be constituted by the Institute and will comprise of the Institution Director, FPM Coordinator, Faculty Experts in specialization and Industry experts.

Duration of the Programme

The fellow shall submit his/ her Thesis only after a minimum period of two years after registration. However, the maximum period allowed for the submission of the Thesis is five years from the date of admission to the Programme.

If a candidate fails to submit the Thesis within the prescribed upper time limit due to reasons beyond his/her control, he/she shall apply to the Director for an extension. If the Institution is satisfied with the candidate's justification, the Director shall permit him/her to re-register to the Programme subject to the payment of re-registration Fee. This re-registration shall, however, be effective only for a period of two years beyond which no extension shall be permitted.

Any break or unauthorized absence from the Programme before registration shall lead to the cancellation of admission. Any authorized break or leave of absence shall not be counted for the minimum period of 2 years stipulated for submission of Thesis but shall be counted in the maximum period of 5 years permissible for submission of the Thesis.

Accommodation

Students are eligible for twin- sharing accommodation in the guest rooms available within the campus subject to its availability during their campus visits. They will be charged as per the Institute norms at 25% of student discount rate.

Shift To Post Graduate Programme

A student admitted to the Fellow Programme is not permitted to switch over to the Post- Graduate Programme in Hospital and Health (PGP) under any circumstances.

Boarding and lodging fee during campus visits are not included in the above fee structure. After completing the academic requirements, the FPM scholar will have an option to join as Research Assistant. This depends upon the availability of such positions in the Institution.

Each FPM Scholar must work mandatorily as TA for a 3 credits course as a partial fulfilment to the degree. They have the option to work as TA for 2 more courses and will be paid a stipend as per the Institute Norms "if these options are availed". This option can be availed in the third or fourth semester of the Programme and based on the requirement of the Institute.

If the candidate is unable to complete the mandatory course work within the stipulated three years, they can get one more year extension based on the discretion of the Director. If the candidate requires one more year of extension, the candidate will be charged an extension fee of Rs 10000/- . The maximum time allowed for thesis submission is 5 years. Beyond which the candidate needs to re-register. A re-registration fee of Rs. 25,000/- will be charged with extension up to two more years.

Merit Based Freeship Scheme

To encourage academically talented individuals committed to pursuing a career in research, IIHMR Delhi is offering financial support to eligible scholars based on merit. The scholars will have full tuition fee waiver on completion of their academic coursework and will be provided additional Rs 25,000/- per month. They will also have the opportunity to work as teaching assistant and participate in the ongoing research projects based on the project requirement. A total of 4 freeship will be awarded.
