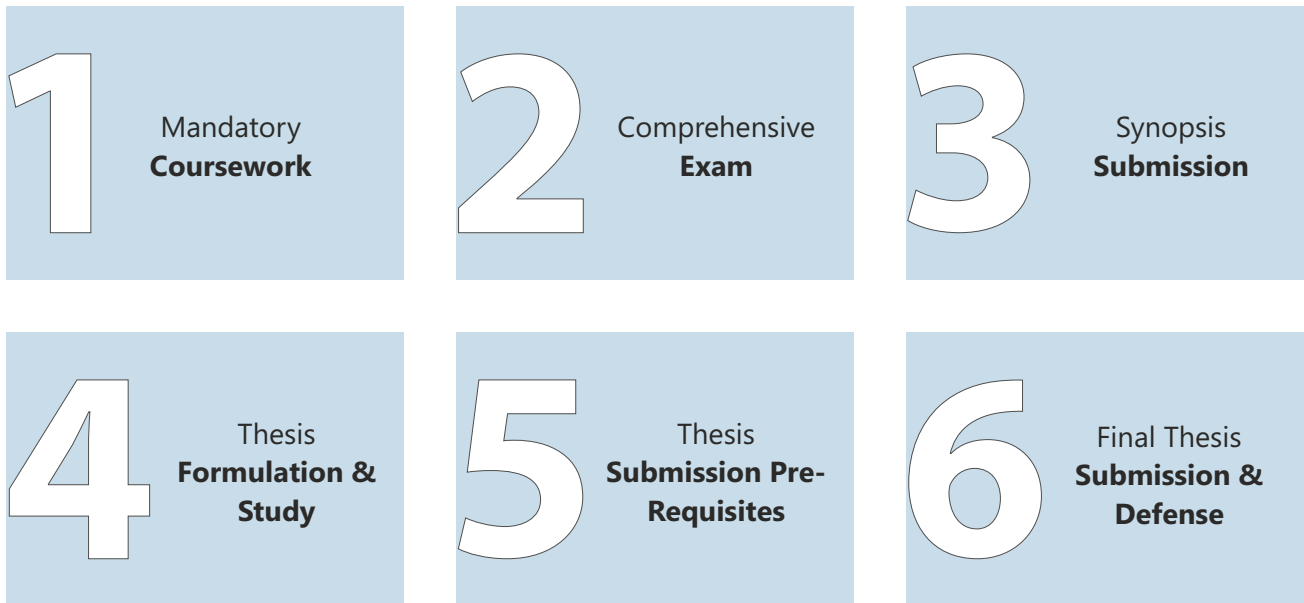

## **DURATION FOR EARNING CREDITS**

All the credits specified above shall be earned within a maximum of three years from the date of admission to the Programme. Extension after the three years shall be approved by the Director for a period of one year with a review of progress every six months. Final approval shall be given by the Director of the Institution.

## **CREDIT COURSE REQUIREMENT**

The candidate shall undergo the courses as given in the course credit table. In the first year, a total of 42 credits is required, which includes a 3-credit general seminar in the second semester and stream specific compulsory and elective courses other than general courses. In the second year, the student shall earn 18 credits: in the third semester the candidate shall undergo advanced courses related to research methods and conduct a stream specific seminar of 3 credits.

## **FACULTY ADVISOR SCHEME**

During the first term of the course work, the faculty working in specialization chosen by the scholar will be eligible to act as faculty advisor. The faculty having mandatory work experience of 2 years in the relevant area and minimum 2 paper publications in the preceding year as per the AICTE guidelines. A faculty advisory committee (FAC) that has the Dean, FPM Coordinator, one more faculty as members will be constituted for each student to advise and mentor the students till completion of the coursework. The student will work with FAC for completion of the course.

## **RESEARCH ADVISORY COMMITTEE**

Upon completion of the course modules the scholar should identify a topic for the thesis and accordingly choose a thesis supervisor (A.K.A advisor) from the faculty and inform the FPM Coordinator. The FPM Coordinator will formally constitute a Research Advisory Committee (RAC) based on the approval from the Director. The committee will constitute six members: - Director, FPM Coordinator, supervisor, internal faculty and two external members (one academician and one industry expert). The student with approval from RAC will file with the FPM Coordinator the approved thesis title. In very special cases, scholars may be allocated an external co-supervisor depending upon the research topic and/or based on the request of the research scholar. The decision to allocate external co-supervisor will be taken by the RAC.



# COMPREHENSIVE EXAMINATION



Each research scholar will be required to undertake a comprehensive examination to get the degree on completion of the course work. The exam consists of two parts: a written (individual modules) and one final oral examination after completion of the course work. The oral examination will be conducted by a committee constituted by the Examination Cell in collaboration with FPM Coordinator and approved by the Institute Director. The grading will be as per the approved process of AICTE. The minimum of CGPA of 6.5 on a 10-point scale or 60% is required for passing Course/ Seminar. A candidate getting less than 60% shall be given one more opportunity to repeat the Course/ Seminar. If he/ she still does not pass in the Course/ Seminar, he/ she shall be terminated from the Fellow Programme. Attendance is mandatory for completion of each course. The policy of attendance will be according to the Institute rules during the course work.



# SYNOPSIS SUBMISSION



Every research scholar should mandatorily submit a synopsis of not more than 100 pages and get it approved before starting the actual project work. Synopsis submission follows three stages.

**Stage 1:** Pre-synopsis Report –After selecting the topic, as a first step the scholar should submit a pre-synopsis report approved by the guide. It should include a detailed survey of related literature, formulation of theoretical framework or model, formulation of hypothesis, data collection techniques to be used, data collection plan, limitations, and plan of analysis. It should be submitted through the guide.

**Stage 2:** Pre-synopsis Seminar: Three weeks after submission of pre-synopsis report, research scholar should give a seminar defending the work proposed before RAC. Any changes suggested by the committee need to be included and the report submitted as final synopsis within two months after submission of pre-synopsis report.

**Stage 3:** Ethical Clearance: The RAC committee after review of the synopsis with tools will forward the same to Institutional Research Board (IRB) to get ethical clearance for the study. Any data collection can be started only after the IRB has no objection to carry out the study.



# THESIS FORMULATION & STUDY



The RAC will all along monitor the student's progress in completing the thesis and will also participate in evaluation processes related to the project work (seminar, synopsis approval, ethical clearance etc). Once formed, the RAC will not be reconstituted except at the initiative of the committee itself or either party acting in consultation with the other. Such exceptions may be permitted on grounds of any substantive change in the topic of the thesis or continued non-availability of any member/s as permitted by the Institute. During thesis work a student is required to keep the RAC members informed of his/her progress. The student is required to submit mid-term progress report once in six months to the RAC.



## THESIS SUBMISSION RE-REQUISITES

The following are pre-requisites for submission of thesis by the candidate.

**1) Requirement for Teaching Assistantship** - Since the purpose of the FPM is to rigorously prepare scholars for outstanding careers in teaching/ research, there is a need to build collaborative research / teaching skills. Therefore, each scholar is required to work with a faculty member as a 'teaching assistant' supporting the faculty in teaching which may include teaching, lecturing / case material preparation, course design, curriculum design, grading, etc. FPM scholars are expected to provide teaching assistantship for a minimum of one course as a pre-requisite to thesis submission. This can be opted in the second or third year as per the feasibility of the scholar and requirement of the faculty. The candidate can work as teaching assistant for a maximum of 3 courses.

**2) Publication Requirement** - The Research undertaken by an FPM scholar is expected to provide sufficient basis for writing papers in refereed academic journals. One of the objectives of the Fellow Programme is to prepare scholars for academic work and research. It is mandatory for the FPM scholar to publish at least two papers in reputed peer reviewed international journals, in well-known classification lists like Clarivate Analytics, Scopus Index Score or journals approved by UGC. In addition, scholars can publish a case in reputed journals (national / international) with relevant impact factor. The scholar should be the first author for this purpose. The scholar must be aware of the anti-plagiarism clause and may submit the teaching case with teaching notes to one of the above-mentioned case collections at one point of time.



# FINAL THESIS SUBMISSION & DEFENCE

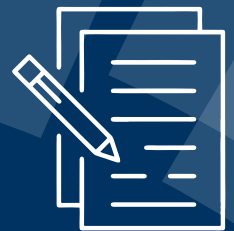
After completion of the work a thesis needs to be submitted with necessary certificates and clearance within a period of 12 months from the date of submission of the Synopsis. The thesis will be evaluated by the Research Advisory Committee. Once approved viva-voce examination will be conducted before a panel of experts where the candidate should defend his/her work. If the thesis needs any modification or changes as suggested by the panel, it should be re-submitted with changes within a year. Only then viva voce examination can be conducted.

If the thesis is rejected by one panel member, then another expert will be requested to evaluate the thesis. If both the members reject the thesis stays rejected.

On successful completion of the viva-voce and on the recommendations of the Institution's Governing Board, the Institution shall award "Fellow in Management" to the Research scholar. The title of the thesis with photo of the scholar shall be mentioned in the certificate of award.



## ADMISSON SUBMISSION



The program is designed to train and skill scholars with good academic background, strong motivation, discipline and keen in conducting good quality research in healthcare management. The candidates should be highly motivated to pursue research or teaching career in academia. Excellent written and verbal communication are must.

### **ELIGIBILITY**

The candidates for the programme must have one of the following qualifications obtained from any of the universities incorporated by an act of the central or state legislature in India, or other educational institutions established by an act of parliament or declared to be deemed as a university under section 3 of UGC Act, 1956, or possess an equivalent qualification recognized by the Ministry of HRD, Government of India, or an equivalent qualification from an institution approved by AICTE. The degrees of candidates from foreign universities must be recognized by the Association of Indian Universities (AIU).

PGDM from Indian Institutions recognized as equivalent to MBA by AIU and approved by AICTE.

OR

Master's degree or its equivalent in any Health and Social Science/ Allied discipline with a minimum of 60% aggregate marks (Relaxation of 5% is given to SC/ST candidates)

OR

Five-year Integrated Master's degree in any discipline, with a minimum of 60% aggregate marks (Relaxation of 5% is given to SC/ST candidates) or equivalent grade point average, obtained after completing the higher secondary schooling (10+2) or equivalent.

OR

Four Year/Eight Semester M.B.B.S/M.D. S/BAMS/ B.Sc. Nursing Bachelor's Degree in Computer Science and Information Technology (B.E./B.Tech.) with a minimum of 60% marks (Relaxation of 5% is given to SC/ST candidates) or equivalent grade point.

AND

2 years of working experience in relevant sectors.

Those appearing for their final examination in the respective discipline can also apply provided they have earlier work experience of 2 years. Such students if selected shall be provisionally admitted provided they complete all requirements in obtaining their master's degree before 30th September of the year of admission. The admission of these candidates shall remain provisional until they produce the mark sheet proving that they satisfy the eligibility criteria. The deadline for submitting the final year mark sheet is 31st December.

Candidates will be assessed based on outstanding intellectual ability, motivation, faculty recommendations and personal characteristics required for an international academic career. There is no requirement concerning fields of study at the undergraduate level, but standard postgraduate entry tests (GMAT / GRE / CAT / JRF) will be used to assess general ability and, if necessary, proficiency in English. If the candidate has not appeared for the above-mentioned exams, he/she should compulsorily attend the Fellowship Evaluation Test that will be conducted by IIHMR.

The fellowship is open to trans gender candidates also.

### AGE LIMIT

There is no age restriction.

### ADMISSION PROCEDURE

#### **Start of the Session**

Admission to the Fellow Programme shall normally be made once a year in the month of April.

#### **Application Procedure**

Advertisements for the program will be made one to three months prior to start of the new session. Advertisements will be made available through print and social media. The application shall be made available in the prescribed format in the Institution and available on the website. Attested copies of all the necessary certificates and testimonials are to be attached with the applications. The candidate must submit an abstract of about 5000 words on the area of research interest (tentative research proposal) along with his/ her application.

## **Selection Criteria**

The following criteria approved by AICTE will be followed for selection of Fellowship program:

- i) Academic qualifications and work experience
- ii) A valid test score in postgraduate entry tests (GMAT/GRE/CAT/JRF) OR in Fellowship Program Evaluation Test (FPET) that will be conducted by IIMR
- iii) Personal interview

The decision of the Institution Fellowship Program Selection Committee (FPSC) regarding admission shall be final.

Communication shall be sent only to the selected candidates. The Institution shall not entertain any queries or correspondence in respect of those not selected.

FPSC will be constituted by the Institute and will comprise of the Institution Director, FPM Coordinator, Faculty Experts in specialization and Industry experts.

## **DURATION OF THE PROGRAM**

A candidate shall submit his/ her Thesis only after a minimum period of three years after registration. However, the maximum period allowed for the submission of the Thesis is five years from the date of admission to the Programme. A six-month extension beyond the aforesaid maximum period of 5 years can be considered at extreme cases.

If the candidate cannot submit the thesis within stipulated time due to reasons beyond control, he/she can apply for re-registration. If the candidate is allowed to re-register, it can be allowed only once and that too for a maximum period of two years only.

If the candidate takes any break or absence without approval before registration, it shall lead to the cancellation of admission. Leave of absence taken after approval shall not be counted for the minimum period of 2 years stipulated for submission of Thesis but shall be counted in the maximum period of 5 years permissible for submission of the Thesis.

The candidate will be required to make visits to the campus for completing the course work that will be conducted mostly during weekends, for comprehensive evaluation and to get experience as Training Assistant for a course work. The course work will be a combination of both offline and online lectures.

## **ACCOMMODATION**

Students are eligible for twin- sharing accommodation in the guest rooms available within the campus subject to its availability during their campus visits. They will be charged as per the Institute norms at 25% of student discount rate.

## **SHIFT TO POST GRADUATE PROGRAM**

A student admitted to the Fellow Program is not permitted to switch over to the Post- Graduate Program in Hospital and Health (PGP) under any circumstances.

Boarding and lodging fee during campus visits are not included in the above fee structure. All scholars will be provided library access to loan books, digital materials, and articles for their fellowship program. They will be also provided computer facilities in the lab and library for their research and course work. At the third and fourth year the FPM scholar will have an option to join as Research Assistant. This depends upon the availability of such positions in the Institution.

Each FPM Scholar must work mandatorily as TA for a 3 credits course as a partial fulfilment to the degree. They have the option to work as TA for 2 more courses and will be paid a stipend as per the Institute Norms "if these options are availed". This option can be availed in the third or fourth semester of the program and based on the requirement of the Institute.

If the candidate is unable to complete the mandatory course work within the stipulated three years, they can get one more year extension based on the discretion of the Director. The candidate will be charged an extension fee of Rs. 10000/-. The maximum time allowed for thesis submission is 5 years. Beyond which the candidate needs to re-register. A re-registration fee of Rs. 25,000/- will be charged with extension up to two more years.
