BACKGROUND OF THE TRAINING PROGRAM:

Among the countries in South-East Asia, Thailand has a strong public health system. The universal Health coverage scheme, which was introduced in 2002, is available to all Thai nationals. According to the World Bank, under Thailand's health schemes, 99.5 percent of the population have health protection coverage.

Healthcare in Thailand is overseen by the Ministry of Public Health (MOPH), along with several other non-ministerial government agencies. Thailand's network of public hospitals provides universal healthcare to all Thai nationals through three government schemes. Private hospitals help complement the system, especially in Bangkok and large urban areas.

Thus, IIHMR Delhi, with its excellent record training and academics organized a training program cum exposure visit on "Health Policies & System in Thailand: Planning & Management Strategies" to Bangkok for the public health professionals of NHM Odisha, in association with Mahidol University, Bangkok

OBJECTIVE OF THE TRAINING PROGRAM:

- To familiarize the Public Health executives, NHM-Odisha with the Public Health System of Thailand.
- To understand the framework of setting up an effective surveillance system.
- To orient the participants on Universal Health Coverage (UHC)

ABOUT THE TRAINING:

Participant's and Co-ordinators details:

The training was conducted for 2 batches, with **Batch I** consisting of 24 participants and **Batch II** with 26 participants. Therefore, a total of 50 officials were benefited with the training. The learning material were provided by Mahidol University which included PowerPoint Presentations of all the speakers.

Program Content covered in the training:

The programs covered the following topics:

- Health System Management in Thailand
- Health System Management in India
- Management of Universal Health Coverage (UHC) in Thailand
- Health Profile Policy and Strategic Planning in Thailand (IHPP)
- NCD Prevention and Management Strategies in Thailand
- Public Health HR Management Under Thailand Ministry
- Thai Health Service System in Covid19 Context

Adopted Training Methodology:

- The training adopted theoretical approach along with the practical and interactive sessions.
- Discussions, group exercises, group presentations engaged the participants all through the training program.
- Participants had the opportunity to visit Ministry of Public Health and gained the practical learning of the functioning of public health system of Thailand.
- English language was used by the trainers to communicate with the participants.
- Besides the academic visit, participants had fun visiting the local sight-seeing places like *Grand* Palace Wat Phra Kaew.

Flow of the Training Program:

Day 1

Dr. Sarawut Thepanondh, Dean, Faculty of Public Health, Mahidol University and Dr. Orawan Kaewboonchoo, Deputy Dean for International Relations warmly welcomed the participants. Representative from NHM Odisha and faculty from IIHMR Delhi also spoke at the inaugural to set the tone of the exposure and the expected learnings.

This was followed by informative sessions about a detailed lecture discussion on the health system of Thailand by Mahidol University Professors. IIHMR Delhi faculty then provided an overview of the health system of India.

The participants were then taken to an outside venue for a welcome dinner.

Day 2

On the second day of the training programme, the participants were received at the Ministry of Public Health by Mrs Waraporn Suwanweela, Assistant Secretary General, National Health Security Office, followed by a discussion on the Universal Health coverage policies of Thailand, which generated a discussion comparing the UHC policies of Thailand and India.

The second session of the day outlined the major achievements in the health sector for Thailand and the challenges faced during COVID-19 crisis.

Day 3

The day started with the session on NCD Prevention and Management Strategies in Thailand, followed by Public Health HR Management Under Thailand Ministry

Dr. Tanarak Plipat, Inspector General, Public Health had an online session with the participants on the actions of the Government of Thailand during COVID-19 crisis which generated a lot of interest and discussion.

Day 4

The participants had been asked to present on the following topics as part of their group work

- 1. Health system management in India and Thailand
- 2. Prevention and control of NCD in India and Thailand
- 3. Pandemic response to COVID-19 in India and Thailand

The participants worked in groups and made the presentations. Dr. Sarawut Thepanondh, Dean appreciated the comparative analysis made by the participants.

This was followed by the Valedictory function during which the d Dr. Sarawut Thepanondh, Dean distributed certificates of attendance to all participants. The participants conveyed their appreciation to the learnings and hospitality provided by Mahidol University through vote of thanks by consultant from NHM Odisha.

The programme culminated with a Farewell Dinner hosted by Mahidol University.

PARTICIPANT'S INSIGHTS

- The feedback received from the participants on the training cum exposure visit was quite affirmative.
- The exposure of the Thailand's Health system gave the participants an insight of the lacunas in their settings and could connect the dots of improvement.
- Also, they realised that where our nation is doing good in the field of public health and how it had bought change in the health system, which still other countries are lacking.
- The participants were quite assertive of bringing change in their own health system by applying the new learnings.
