



Online Management Development Program on Emerging Trends in Biomedical Waste Management with Special Reference to COVID-19 Waste Date: October 26-28, 2020 (1:30 – 5:30 PM)

RATIONALE

Ministry of Environment and Forest (and Climate Change) framed for the first time in India as well as in the Southeast Asia, the Biomedical Waste (Management and Handling) Rules in 1998. These rules have been revised in 2016 with amendments in 2018 & 2019. With the onset of COVID-19 pandemic, the CPCB has come out with Guidelines for the management of biomedical waste from COVID-19 isolation wards, ICUs, quarantine homes and homecare suspects or patients.

It has drawn high interest among public | experts, ICMR, media, Indian Society of Hospital Waste Management, CPCB and others, for the safe management of biomedical waste to protect the healthcare workers, sanitation workers and the public at large. Besides, the segregation of biomedical waste at point of generation in different color coded bags-bins, personal protective equipment (PPE), pretreatment, storage and safe disposal to Central Biomedical Waste Treatment and Disposal Facilities (CBMWTFs) are other crucial issues that call for detailed discussion and implementation in letter and spirit.

OBJECTIVES

- Demonstrate their understanding of the BMW Rules and the latest guidelines issued by the CPCB.
- Manage the biomedical waste-Covid-19 waste in their HCFs, quarantine camps and home isolation in a safe and scientific manner.

- Follow the basic principles of “Reduce-Reuse-Recycle”.
